April 27, 2025 – 0440 hours

Officers responded to a business alarm on State Route 725. Confirmed FA.

April 27, 2025 – 1028 hours

A traffic complaint was reported on Wilmington Dayton Drive after a motorist failed to stop for a school bus. Officers cited the driver.

April 27, 2025 – 1226 hours

Officers were dispatched to W. South Street for a juvenile complaint involving a possible assault.

April 27, 2025 – 1422 hours

Officers assisted a motorist with a disabled vehicle on S. Belleview Drive.

April 27, 2025 - 1701 hours

Officers assisted with a vehicle unlock on W. Franklin Street. Entry gained.

April 27, 2025 – 2246 hours

Officers responded to Hillcrest Drive on a domestic dispute. After further investigation, it was determined that no violence or threats had occurred. Officers stood by while the parties separated for the night.

April 28, 2025 - 0351 hours

A suspicious vehicle was reported on State Route 725. Officers searched the area, but the vehicle was GOA.



April 28, 2025 – 0808 hours

While on patrol, a motorist flagged down an officer to give them a purse that was found in the roadway on Moss Oak Trail. After contacting the owner, it was determined that the purse was stolen sometime overnight from the victim unlocked vehicle, along with other items that were not recovered. The investigation is ongoing.

April 28, 2025 – 2224 hours

Officers conducted a traffic stop on W. Franklin Street. After further investigation, it was determined that both subjects in the vehicle were wanted by another agency. The subjects were transported to the Greene County Jail to await pickup.

April 29, 2025 – 1753 hours

Officers were dispatched to Knob Hill Drive on a soliciting complaint. Officers located the subjects and verified they did not have a valid solicitors permit. They left the area without incident, and no further complaints were received.

Officers responded to assist the fire department with a house fire on Portage Path. All residents were able to evacuate safely, and the Red Cross was called in to assist the family. The fire is believed to be accidental, and criminal activity is not suspected.
