An unwanted subject was reported on S. Main Street. The subject was no longer on the property, but the property owner asked for a trespass warning to be issued.

Officers were dispatched to Hess Road for a neighbor dispute.

May 14, 2025 – 2032 hours

Officers were made aware of a hit-skip crash that occurred on Wilmington Pike. While on patrol, Bellbrook officers located the vehicle and initiated a traffic stop on E. Franklin Street. After further investigation, the driver was placed under arrest for OVI and open container and transported to the Greene County Jail. The crash on Wilmington Pike was under investigation by STPD.

Officers responded to a neighbor dispute on Hess Rd. One subject was issued a trespass warning.

May 15, 2025 – 1541 hours

A welfare check was requested on Upper Bellbrook Road for a juvenile that fell off of a bicycle. The juvenile checked OK and officers assisted with contacting the parents.

May 15, 2025 – 1702 hours

Officers were dispatched to W. Franklin Street on the report of a domestic dispute. After speaking with all parties, it was determined the dispute was verbal only and no threats had been made. The parties agreed to separate and no further calls were received.

Officers responded to Ivy Crest Drive to assist the medics with an unresponsive subject. The resident was pronounced deceased on arrival. No foul play or criminal activity is suspected.

Dispatch received several phone calls regarding a reckless driver on State Route 725. Officers checked the area and located the vehicle at W. Franklin and S. Main Street. After observing multiple traffic violations, a traffic stop was initiated. The driver was arrested for OVI and open container and transported to the Greene County Jail.
