August 3, 2025 – 2218 hours

Officers responded to a suspicious person complaint on Lakeview Drive. Officers checked the area but were unable to locate.

August 4, 2025 – 0034 hours

A welfare check was requested on Ryder Court. All residents checked OK.

August 4, 2025 – 0903 hours

Officers were dispatched to a suspicious vehicle in the roadway on Vemco Drive. Officers contacted the owner, and the vehicle was moved to the driveway. No signs of criminal activity were found.

Officers were dispatched to a possible breaking & entering complaint on S. West Street. Witnesses stated a female subject with an unsecured dog appeared lost and was going onto various porches and knocking on doors. It was determined that the subject entered a home on S. West St. Officers later located the subject at a house nearby and confirmed that they were lost. The dog owner was cited for dog at large and the female was cited for criminal trespass. The female was trespassed from two properties on S. West Street.

Officers assisted with a vehicle lockout on W. Franklin Street. Entry gained.

A suspicious person was reported on E. Franklin Street. Officers located the subject and verified there was no cause for complaint.

Officers responded to Lakeman Drive on a suspicious persons report. The complainant advised a group of males were sitting in his front yard. Officers located the subjects and verified they were contractors working in the area.
