August 10, 2025 - 1721 hours

Officers were dispatched to assist the medics on Eckworth Drive.

August 11, 2025 – 1952 hours

Officers responded to Lower Hillside Dr. on a possible telecommunications harassment complaint. No charges requested at this time.

August 12, 2025 – 0712 hours

Officers were dispatched to Fowler Drive on a residential alarm. Confirmed FA.

August 12, 2025 – 1842 hours

A resident on E. Franklin Street requested to speak with an officer regarding questions about her landlord. The complainant was advised this is a Civil issue and advised to contact an Attorney or the Court.

August 13, 2025 – 0825 hours

Officers assisted with a vehicle lockout on N. Belleview Dr. Entry gained.

August 13, 2025 – 1108 hours

Officers responded to Regent Park Drive on a welfare check after dispatch received a 9-1-1 hangup call. The resident checked OK, but it was discovered a verbal dispute had occurred. No threats or violence had occurred, and officers stood by as one party gathered personal items and left the residence.

August 14, 2025 – 1433 hours

Officers responded to assist the medics on River Birch Drive.



August 15, 2025 - 1149 hours

Officers responded to W. Maple Street for a dispute, past occurred. After speaking with all parties involved, it was determined there was insufficient evidence to file charges. The complainant requested the other party leave the property and officers stood by as they left without incident. No further complaints were received.

August 15, 2025 – 1816 hours

Officers were dispatched to Crescent Court on a complaint involving dogs left unattended in a neighbors yard. Officers checked the area but were unable to locate.

August 15, 2025 – 1900 hours

Officers responded to a family dispute on Tampico Trail. It was determined that the dispute was verbal only and no violence or threats had occurred.

A welfare check was requested on a subject whose phone was pinging on Little Sugarcreek Rd. Officers searched the area but were unable to locate. Officers later located the subject at their home, and they checked OK.

A welfare check was requested on a pedestrian on E. Maple Street. The subject checked OK, and officers assisted them in returning to their home.

A welfare check was requested after the caller heard people arguing in Bellbrook Cemetery. The subjects were gone prior to officers arrival. They were later located in Sugarcreek Township and checked OK – verbal disagreement only.

August 16, 2025 – 2022 hours

Officers responded to a residential alarm on Justin Court. Confirmed FA.



August 16, 2025 – 2039 hours

Officers were dispatched to a suspicious persons report on Belair Circle. Officers located the subjects and verified they were contractors working in the area. No cause for complaint.

August 16, 2025 – 2245 hours

While on patrol, a resident on Amy Brooke Circle informed an Officer that they saw a suspicious person on their Ring Doorbell. Officers checked the area but were unable to locate. No further complaints were received.
