

NARRATIVE
At approximately 1606hrs on 01/23/2026 Unit #1 was traveling eastbound on Ryder Court (alleyway behind Key Bank) at approximately 5mph and when at N. Main Street (non-controlled intersection) failed to yield the right of way to southbound traffic. In doing so, Unit #1 collided with Unit #2 which was traveling southbound on N. Main Street at approximately 0-5mph (stated speed, slowing to stop for red light traffic ahead).


